1. Students admitted under general category and seeking exam fees concession under SC/ST/OBC category need to contact Academic Section with hard copy of valid caste certificate before online exam registration.
2. **For any queries students shall contact Academic Section on 0832-2336406 or email on [enquiry@gec.ac.in](mailto:enquiry@gec.ac.in)** (email sent on any other email id will not be considered) on or before last notified date.
3. Student shall pay exam fees online at the time of registration, before last notified date. It is advised to view help files before making online payment.
4. Students can change the registration details before payments of exam fees.
5. Online exam registration/application will be freezed after payments of exam fees.
6. The registration details can be viewed under exam registration fees.
7. Students are advised to generate exam registration slip after payment of exam registration fees and save the softcopy for reference. (Do not submit registration slip in the Academic Section)
8. ATKT Students of Semester-III are eligible to register for Sem-III Examination.

### C I R C U L A R

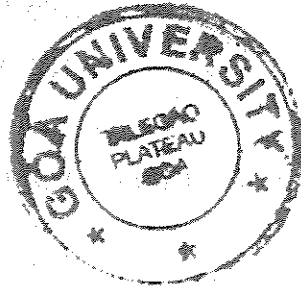
Principals of affiliated Colleges offering Undergraduate Engineering Programme are informed that in view of the introduction of NEP 2020 based curriculum from the academic year 2024-25, the Academic Council in its meeting held on 14<sup>th</sup> June, 2024 has resolved to permit the students of the existing ordinance to keep terms to next higher Semester for the academic year 2024-25, 2025-26, 2026-27 as applicable, as a one-time condonation. These students are required to clear all their backlogs within the prescribed maximum duration to complete the Programme as detailed below:

1. Students who are presently in the first year (Academic Year 2023-24) are permitted to keep terms irrespective of the number of backlogs and are required to clear all their courses within the prescribed maximum duration to complete the programme.
2. The students presently in first year shall be allowed to keep terms(ATKT) at every semester as such a manner that they shall complete instructions, obtain passing grade in term work and attend semester end exam, irrespective of number of backlogs and irrespective of any other conditions of eligibility for admission to the term/semester including minimum attendance as one time condonation.

3. A student who has not kept term for the Semester II of Academic Year 2023-24 shall be transferred to Semester I of the revised scheme RC 2024-25.
4. For the students currently eligible for Semester IV and Semester VI, allowed to keep terms (ATKT) is not applicable. However, the students shall enroll and complete instructions along with students of the last instructional batch (Academic Year 2023-24 batch), irrespective of number of backlogs and irrespective of any other conditions(s) of eligibility for admission to the term/Semester.

The Dean, Faculty of Engineering, Principals of the affiliated Colleges offering Engineering programme are requested to bring the above to the notice of all concerned.
