**REGISTRATION FOR (M.E. Non-NEP) December 2025 Examination**

All the eligible M.E. students of all Engineering branches appearing for the examination of **Semester V (Regular) and Semester-I to VI (Repeat)** of **December 2025** are hereby informed to submit duly filled examination form (Hard copy/Offline mode only) along with examination fees from **30/09/2025 to 10/10/2025**. Last date for offline submission of application forms by the students (with late fee Rs. 355/-) is **14/10/2025**.

Examination forms may be collected from Academic Section. Duly filled Exam form along with the Pay-in-slip should be submitted at Account Section in the Main building. The amount should be paid in Union Bank of India favouring Ms **Goa College of Engineering** Account No. **520101257888568 (Bank - Union Bank of India, Branch - Farmagudi)**

All the final semester IV & VI (part time) students shall submit examination form from **30/09/2025 to 10/10/2025**. Last date for offline submission of application forms by students (**with late fee Rs. 355**) is **14/10/2025** and four copies of the Dissertation and soft copy on CD (Wherever applicable) by **24/11/2025**. Dissertation approval sheet in terms of the provisions of the Ordinance OC - 11A.6 (ii) has to be enclosed. The Dissertation should meet the requirements of Circular No. GU/Exam/55/2016/1633 dated: - 17/02/2016.

Only physical (Hard copy/offline mode) exam forms will be accepted. No forms will be accepted after 14/10/2025 under any circumstances.

Students shall compulsorily mention the **ABC REGISTRATION NUMBER** on the top of their respective Examination Forms, Name as per the B.E Marks sheet and Permanent Registration Number. Incomplete forms will be rejected without giving any further notice.

The students who have failed in any of the paper/ papers and have applied for the revaluation, they may fill the form after the results of revaluation within 2 days of the date of declaration result. However, they should fill the form for the semester they are eligible for. (Note: This does not apply for the students who have passed and have applied for the revaluation.)
